In this statement, "we" or "us" refers to "AI BVALUE" (hereinafter "AI B VALUE"), and "third parties," "third persons," or "third entities" refers to anyone other than us and the user.

4. What Personal Data We Collect

4.1. Information We Collect About You When you use the Application and its core functionalities, for example, when checking billing information or contacting customer service, relevant information is recorded on our servers. Additionally, we collect information regarding the quality and usage of our services and applications. Furthermore, we give you the option to create your profile by submitting your own data. The Application stores your username and password so that you do not have to enter your credentials for each new session to use specific functionalities of the Application (e.g., modifying a business plan).

- Device brand and model
- Operating system
- Firmware version
- Hardware capabilities
- Language

4.3. We Also Collect Information About Your Use of the Application, Such As:

- When and how often you use the application
- Your choices and navigation within the application

5. How We Use Your Personal Data

- **5.1. To Provide You with Customer Support Services** For example, we can offer you advice to resolve any issues or concerns that may arise while using the application.
- **5.2. To Improve Our Services** We analyze the data we collect to draw conclusions that help us improve the services provided by the Application. This processing may include, for example:
 - Enhancing our business models and offers based on insights into application usage.
 - Improving the performance and design of the Application by understanding which features are popular.

The above information is aggregated and anonymized, ensuring that it does not identify you as an individual. We do not intend to use this information to personally identify you or any other individual, and we have taken appropriate technical and organizational measures to prevent this.

- **5.3. Commercial Promotion and Profiling** With your consent or based on your choices in the Application settings, we will process your data alongside other information we hold about you to send personalized marketing communications. For example:

AI B VALUE may retain anonymized statistical data for a longer period, but this data does not identify you as a user and will not be used in a way that compromises your privacy.

How We Protect Your Personal Data** AI B VALUE recognizes the importance of personal data security and electronic transactions and has taken all necessary measures using the most modern and advanced methods to ensure maximum security. We have specialized security teams that continuously review and improve measures to protect your personal data from unauthorized access, loss, disclosure, or destruction. We do not take responsibility for any unauthorized access or loss of personal data beyond our control. We are committed to keeping your personal data and account information secure and not disclosing it to third parties.
